



## Registration rules of the FITCE2020 Conference

1. The FITCE2020 Conference to be held September 28-29, 2020 in Krakow, Poland, is the event of the series, sponsored by the <http://www.fitce.eu/en> . The organizers of the Conference is the the Polish Association of Telecommunication Engineers (SIT) with PLNOG cooperation .
2. The Polish Association of Telecommunication Engineers, located at 11 Kaliska Street, lok. 406, 02-316 Warsaw, shall be hereinafter referred to as the “Organizer”.
3. The Organizer may be contacted in person at the Organizer’s office, or by regular mail sent to the Organizers’ postal address, and also by electronic mail sent to [zarzad@sit.org.pl](mailto:zarzad@sit.org.pl).
4. The financial service of the conference shall be ensured by the Organizer.
5. To participate in the conference, one is required to register <http://fitce2020.pl> and pay the fee to the Organizer within the time limit defined there. The person who registered and paid the conference fee shall be hereinafter referred to as the “Participant”.
6. The conference fee is to be paid by payment card or wire transfer.
7. The online card payment is serviced by eCard S.A. and the the following payment cards are accepted:

  - b. Visa Electron,
  - c. MasterCard,
  - d. MasterCard Electronic,
  - e. Maestro.

9. Each Participant has the right to withdraw from the contract within 14 (fourteen) days from the date of the conference fee payment, as per art. 7 section 1 of the law of March 2, 2000, concerning protection of certain consumer rights and liability for damage caused by a hazardous product (Journal of Laws of 2000 No. 22, item 271, as amended).
10. If the withdrawal takes place before June 30, 2020, the paid conference fee, reduced by the administration fee equal 20% of the payment, shall be reimbursed to the Participant within 14 days from the date of receiving by the Organizer a written statement of withdrawal from the conference participation by the Participant. In case of card payment the amount shall be reimbursed directly to the Participant's card.
11. If the withdrawal takes place after June 30, 2019, and/or a Participant fails to attend the conference, the conference fee shall not be reimbursed.
12. Any complaint of a Participant shall be examined within 14 business days at the latest, counting from the date of receipt of the complaint by the Organizer.
13. Should the Organizer fail to take a stand regarding the complaint of a Participant within 14 business days counting from the date of receipt of the complaint by the Organizer, it shall be assumed that the Organizer found the complaint justified.
14. The Organizer shall ensure that personal data of each Participant is processed solely for the purpose of implementing the FITCE2020 Conference.
